



## **Vote of the 2015-2016 Executive Committee February 27, 2016**

The 2015-2016 Executive Committee members, International President, Jim Kokocki, DTM; International President-Elect Mike Storkey, DTM; First Vice President Balraj Arunasalam, DTM; Second Vice President Lark Doley, DTM; and Immediate Past International President Mohammed Murad, DTM, ratified International President-Elect Storkey's proposed appointments of members to the 2016-2017 International Leadership Committee (ILC) by unanimous consent.
